YMCA 'WINTER TRIAL PROMOTION' - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- c. \$0 Join and Four Weeks Free Offer
 - i. Sign up for a membership and receive a \$0 joining fee and four weeks free.
